V. A. & R. Commission

It has been a banner year for our veterans and their families with the help and support from the Detachment of New York Sons of The American Legion. First of all our second annual "They Marched For Us, We Walk for Them" Walk-A-Thon realized \$31,148 this year in pledges and donations. Many new ideas were used to help achieve this total. The sale of walk-a-thon T-shirts in Ontario County to the selling of paper boot cut outs at American Legion Post # 20 in Clinton County. Washington County collected over \$7,000 in local business donations. Scott Henry a Sons of The American Legion member from Candor, Tioga County and his wife Donna organized a motorcycle ride and collected \$4,734 for this year's walk. This was done the same day as Unit members from the American Legion Auxiliary in Candor held their walk and turned in over \$3,900. Scott by the way will be recognized at a ceremony later this month at his American Legion Post in Candor. As we did this year the Department of New York American Legion Auxiliary has received there half of the proceeds with the carry over from last year gained them a check for \$16,000 for their VA&R programs and the checks have been sent out to the 13 VA Hospitals, the 5 New York State Veterans Homes and the Fisher House for \$842 each. This is an increase from \$631 that was sent last year. At this time I would like to hand out special Certificates of Appreciation to Sons of The American Legion members who responded to the call and organized walks and special fund raisers to make this project a success.

The numbers on the reports are outstanding. To highlight some of our accomplishments this past year I am proud to inform all the delegates here at this convention that we as a Detachment did the following for VA&R:

Another very successful but challenging year is coming to a close. With the upheaval in the economy, job uncertainty and parents being deployed, more kids and youth organizations needed our help more than ever before, and that was only on a local level. All of the National Programs supported by the Sons of the American Legion and the American Legion Family experienced the very same situations, whether funding shortages or lack of volunteers, they all needed our help.

It makes me so proud to say that, again, WE STEPPED UP!!!! With our own members experiencing some of those very same issues, we put our own personal travails aside and gave of ourselves, and then we gave some more. Whether it was monetary donations, or manpower hours, we answered the call. Last year our total donations under C & Y were \$76,651.00 and 6842 hours of our time. For those of you that aren't aware, National Vice Commander East, David Downey pointed out that one of National Commander Tommie Cisna's "pet projects" was Josh and Friends. Well, in about ½ hour, we raised enough money (over \$1000) to present each Detachment Vice Commander with 5 Dogs to deliver in their area. I know in my county,

Onondaga, we have formed a committee to carry this on in our area and are working to include all Legion Post and Auxiliary Units to participate and grow the program and I hope that others have adopted a similar program, in fact the chairman for that committee, Dave Edgin is here today.

I want to take a couple of minutes to commend 2 individuals. The first person I want to single out isn't here and in fact, isn't even a Sons Member. But, I want to talk about her because she is a great example of taking an adverse situation and turning it into an incredible positive. That person is Pat Martin. Pat is the President of the Mattydale Auxiliary Unit #1832 and the mother of our Squadron Commander, George Martin, Jr. A couple years ago, Pat had very serious and extensive back surgery, to the point that 2 rods were inserted the length of her back. After being told by her doctor she will be lucky to walk normally, let alone resume any other extensive activities, Pat told her doctor, and I will censor the conversation that not only would she do many things she did in the past, but, on her 68th birthday, she would bike 68 miles from Syracuse to Rome over 2 days to raise money for the Gollisano Children's hospital in Syracuse. She recruited 24 others (including one dumb Children and Youth Commission Chairman) to join her. Well, not only did she do the 68 miles, but, as of Monday, the donations are up to \$10,000 which is enough to pay for a special sensory therapy room at the Children's Hospital. There were several Sons members that served as volunteers for this bike ride and helped pull this off.

We again, had a successful year with Legislation. Our On-the-Hill Days in Washington went smoothly this past February with at least 10 SAL members present from the Detachment of New York. Our On-the-Hill Day in Albany also was productive.

Our numbers do make a difference, some of our districts are not represented in the Albany Days which could always be stronger but we do set up meetings with state representatives and senators and our issues and the issues of the Legion are shared. This year we had the opportunity to meet with several representatives as well as both Senators Gillibrand

and Schumer. That was a first, in at least the last few years. We hold a briefing before we go out on the Hill to set the priorities for everyone's visitation and coordinate whenever possible with the Legionnaires.

Our presence is known. The SAL connection is strong on both the national and State levels but we could always use your involvement. The legislation that was passed this year was quite remarkable. Almost every major Legion issue was addressed or approached. The benefits to Veterans both current and past received much attention this year and significant in roads were

made for all.

I guess I'd like to think it was a combination of both of those facts but the bottom-line is that Veterans have reaped the benefits this year.

We look forward to preparing for the 2009-2010 legislative year. I wish to thank all the committee members that have paid serious attention to our charge as well as all those who joined us in our visits to our representatives. A memo from Iraq by Lt. Riordan, Navy to Ken Kraetzer after having learned of the identification of the remains of MIA Lt. CDR Speicher.

I had just turned nine-years old when the air-strikes began and Lt. Cmdr. Scott Speicher was shot down over western Iraq. A catalog of my memories from the first Gulf War consists of writing letters to soldiers in school, collecting Desert Storm trading cards (I still have an extensive collection, which my wife is about to discover when some boxes arrive from long-term storage in a few weeks), and a parody on a local radio station of "Lifestyles of the Rich and Famous" visiting one of Saddam Hussein's palaces. I didn't know anyone that went to Iraq during that time. There was no great shake-up in my life. (For reference: Most of the people I currently work with participated in Operation Desert Storm.)

I was in high school when I read the Wilfred Owen's anti-war poem. Under the title, "Dulce Et Decorum Est Pro Patria Mori" [It is sweet and fitting to die for one's homeland], Owen describes the horror of a gas attack, asking who could ever tell their child about the

glory of war if they knew the reality.

I was a plebe at the Naval Academy when I learned about Scott Speicher. We were not at war. He was a young Naval Academy graduate who had been shot down during the first Gulf War. I immediately clung to his story...he was the closest I was to someone who had sacrificed their life for our country - there was no doubt in my mind he was a hero...and he had not yet been brought home. I wore a POW/MIA bracelet with Captain Speicher's name for several years (until I replaced it with one more personally related).

*Military Uniform trivia: In 1972, the Secretary of the Navy added a provision to uniform regs: "Wearing of POW/MIA bracelets is authorized for Navy and Marine Corps personnel -- at any time they desire, including while in uniform -- as an expression of concern for their fellow servicemen who are prisoners of war or missing in action."

**Livestrong bracelets are NOT authorized.

I was at the Naval Academy, when I studied the Classics and learned where so much about the birth of

our military ideals.

I was sitting in my CHU just a few weeks ago, when I had the opportunity to see the film "Taking Chance," about a Marine officer who escorts the body of a fallen Marine. The film follows the great care with which the body is returned, while Lt. Col. Strobl contemplates the value of his own service.

How is all this related? These are the memories that race through my mind over and over as I try to deconflict my thoughts...usually while on the treadmill, with no other work to distract me. There is no reprieve from the reminders that war is terrible...but there are greater evils. The ranks of those that serve in uniform are filled with idealists...idealists who will never "lose" their lives, although some will "give" their lives for this country and more importantly the ideals it represents.
