

**MINUTES OF THE 39<sup>th</sup> ANNUAL DETACHMENT CONVENTION**  
**July 18 - 19, 2013**  
**Niagara Falls Convention Center**  
**Niagara Falls, New York**

**FIRST SESSION – JULY 18, 2013**

- Commander Knapp called the Convention to order at 9:00 AM.
- The Colors of our Nation were placed by the Detachment Color Guard and the body saluted.
- Commander Knapp recited the POW/MIA Ceremony as the Master Sergeant placed the POW/MIA banner.
- Acting Chaplain Burtch offered the Opening Prayer.
- V/C Santa Croce led the body in The Pledge of Allegiance.  
V/C Green led the membership in the Preamble.
- Adjutant Robert Avery read the Call to Convention, Roll Call of Officers, and Roll Call of Counties, which indicated a quorum was present. Present as a guest to the Convention was National Commander of the Sons of The American Legion Christopher Huntzinger (PA), Leading Candidate for Sons of The American Legion National Commander Joseph Gladden (MD).

**1.00 REPORTS**

**1.01 Convention / Niagara Falls General Chairman Hewitt** reported that the Meet the Candidates Luncheon will be held at 12 PM just outside the room we are meeting in. The tickets for the Installation Luncheon are still available. Busses will leave the Hotel at 1:30PM to go to the Sikora Post and return at 4:30PM. **1.04 Finance Chairman David Lee** read the current budget and where we stand to date. Chairman Lee read the proposed budget. He then read changes to Expense authorizations and schedule A. Chairman Lee thanked all the members of the commission for their hard work.

**1.05 Internal Affairs acting Chairman Jarvis** had the following Chairman give their reports.

**Roy Mezzapelle MT&D.** This report is an update to the report presented at the 2013 Mid-Winter Conference. At the 2012 Fall DEC meeting, the Member Training & Development Committee reviewed our current presentations – the Leadership Workshop, and the Advisors Seminar. We agreed that the Leadership Workshop was fine as-is, but the Advisors Seminar needed to be adjusted to reduce the presentation time. After presenting last year’s Seminar at the 2012 Mid-Winter Conference, I identified items that could further reduce the presentation time for this year’s Seminar, and discussed this with the Committee Members and adjusted the presentation accordingly. Moving forward, I have again identified other content to eliminate that will further reduce the presentation time for the 2014 Seminar. This will be brought to the Committee’s attention at this year’s Fall DEC Meeting. Another issue that will be discussed at the Fall DEC Meeting will be to consider offering the Advisors Seminar every other year, and alternating it with a different presentation. Attendance at the Seminar is steadily decreasing, and I believe it’s because it’s basically the same presentation year after year, as the role of the Advisor hasn’t changed all that much in the recent past, and neither have the many of the Advisors. One topic that comes to mind is “How to Start a Squadron.” This would be a fresh topic, and one I believe will spark some interest and be well attended, and produce a positive outcome for the Detachment.

To offer “Continuing Education” programs to the members of the Detachment & Department, the Chairmen of two Detachment Commissions/Committees conduct workshops during the Mid-Winter Conference, giving formal presentations to the membership, explaining the purpose of the Commission/Committee, with two goals in mind – First, to raise awareness of what the purpose of the Commission/Committee is, how it operates, and how the membership can help, and Second, to hopefully spark interest in the membership to assist the Commissions/Committees in reaching their goals by bringing this information back to their local Districts, Counties, and Squadrons, and putting it to good use. This year’s presentations were “Veterans Affairs & Rehabilitation” and “Public Relations”. Any Committee Chairman interested in presenting at next year’s Mid-Winter Conference should feel free to talk to me before the end of Convention.

The Member Training & Development Committee remains committed to furthering the education of our membership by presenting new programs, updating existing programs, and assuring that all training needs within the Detachment of New York are addressed in a timely manner. I sincerely thank the members of the Committee, David L. Downey, Gerald M. Ketchum, Gary W. Denmon, and Thomas G. Smallcomb, for their dedicated service to the Committee and the Detachment.

**Membership Gaither Espy.** As we wrap up our membership year I would like to thank the membership commission for all the hard work they have given to keep our membership strong. Things have been a little tough this year, we as a Detachment have not hit one target date. We can however reach the 105% target date on July 24, 2013 if we all keep plugging away. Currently we are at 97.38%, we only need 758 to reach 100%. There are 27 Counties at 100% or better. Congratulations to all of them and great job to Warren County from the 4<sup>th</sup> District on top of the list with 132.61%. Only 2 Districts have reached 100%, they are the 2<sup>nd</sup> with 101.20% and the 4<sup>th</sup> with 100.65%. Currently our renewal rate is 86.55%, this is about 5% lower than we

usually are at. Let's get working on those renewals so we can get New York to the front of Commander Huntzinger's band wagon.

**Convention / Binghamton General Chairman Hewitt** reported that next year's convention will be 2014 Albany and 2015 will be in Buffalo. Starting in 2016 all conventions for the following five years will be in Albany per the Department Executive Committee.

Acting Chairmen Jarvis stated that if you are submitting reports for judging on the Detachment and National levels you must fill out the consolidated report form in its entirety. That includes prior year and current year membership.

**Jefferson County made a motion to accept the report which was seconded and carried.**

- 1.06 Legislative Chairman Gibbs** Two main events characterized the 2013 year of the Detachment Legislative Commission: the On-the-Hill Days in Albany and in Washington, DC. The first main event was held on February 24-27, 2013 when the SAL Detachment of NY attended the On-the-Hill Days in Washington, DC. Seven (7) members of the Detachment were present; Commander John Knapp Sr., Legislative Chairman Doc Gibbs, National Legislative Chairman David Lee, National Asst. Adjutant Robert Avery, National Executive Committeeman Jerry Ketchum, Commander's Aide John Chang, and Legislative Committeeman from Bath, NY - David Perry. On Sunday we toured the various memorials and went with National SAL Commander Chris Huntzinger where he laid a wreath at the Tomb of the Unknown Soldier. Monday we had a series of meetings including the Legislative Meeting where the Legion legislative priorities were outlined and discussed and then we took time to accompany Commander John Knapp to the Vietnam Memorial

where he placed a wreath in honor of a fallen comrade. Tuesday morning we all attended the “Know before You Go” breakfast meeting and then went to Capitol Hill to meet with our respective Congressman/women. Preset meeting appointments had been arranged by Chairman Doc Gibbs prior to coming to DC. The brochure with our Legislative Priorities had been passed out at the breakfast meeting and was available for distribution to each of our Congressional representatives. We had meetings with representatives or aides of the following: Louise Slaughter, Nita Lowey, Chris Collins, and Thomas Reed. Several members of the Detachment ate lunch at the Senate Cafeteria in the basement of the office buildings. After the visitations an email was sent to Jerry Ketchum, our NEC, that his Congressman, Thomas Reed had co-signed the Stolen Valor Act and an email was sent to Doc Gibbs stating that Congressman Collins will cosign the Tuition Fairness Act HR 357– that just shows the immediate impact that our group can have. The Stole Valor Act was ultimately passed and made law later in the spring.

## Priorities

### THE AMERICAN LEGION LEGISLATIVE PRIORITIES for the 113<sup>th</sup> Congress

#### Protecting veterans and DOD from the harmful tolls imposed through privatization

The American Legion opposes and supports the need for a fiscally responsible government, and looks forward to working with the new Congress to develop deficit-reducing programs that do not degrade the nation's ability to defend itself or further assure the earned benefits currently being received by our nation's military veterans. **HR216/113**

#### Mental health care

The American Legion is deeply concerned about access to quality mental health care for veterans. With uncoordinated numbers of servicemembers returning from Iraq and Afghanistan with TBI and PTSD, a full 60 percent of veterans are not even receiving the VA for health care. The American Legion is committed about these veterans falling through the cracks, especially as VA reports indicate as many as 23 veterans died of suicide a day as of 2010. The American Legion urges congressional oversight to ensure full staffing and funding of mental health programs, and increased reliance on other resources to address veterans, such as intensive treatment centers.

#### Oppose any further increases in TRICARE fees, including prescription drug fees

The American Legion stands along against those who would shake the promise made in the contract with those who serve in our nation's defense. We strongly oppose any proposed degradation of the health care promised to retired servicemembers when they entered through increases in fees by TRICARE for Life, increases in pharmacy or plans or any further breaches of the contract of health care given this nation and those who have defended it.

#### Stolen Valor Act

In United States v. Alvarez, the Supreme Court ruled the 2002 Stolen Valor Act was unconstitutional and left the door open for a more carefully tailored law

to criminalize profiting from lies about military service. The American Legion supports legislation to restore the criminality of false about military service and misused decorations. **HR216/113**

#### VA claims backlog

America's veterans deserve better than a disability claims system riddled with delay and backlog, where over 80 percent of claims are delayed over 180 days to complete. The American Legion believes VA can only change the bureaucratic culture causing these delays by implementing a work credit system that places as much incentive on getting a claim done right the first time as it does on the size volume of claims processed.

#### Disabled veterans tax-relief cut

VA disability compensation should not be offset from military retired pay regardless of the VA rating percentage, nor should the Survivors Benefits (SB) from military Survivor Benefits Plan (SBP) annuities. The American Legion supports legislation that would completely repeal these unjust offset. **HR333/HR333/HR333**

#### DOL-VETS and TAP

The VETS program should be kept in its rightful place within DOL, OIGVA and OIGVA should be solely focused on getting veterans jobs. Congress has already passed legislation to improve the Transition Assistance Program, but DOD is improperly executing it. The American Legion looks forward to working with Congress to ensure that TAP offers the services and information necessary for transitioning servicemembers and veterans.

#### Small business verification

Businesses owned by veterans have earned the right to compete fairly through federal procurement. The American Legion calls on Congress to ensure that the federal government makes its 2 percent procurement goal for the full time military and dependent 40% address and meet the current small business verification program.

#### End veteran homelessness

The American Legion strongly supports the administration's goal of eliminating veterans homelessness by 2015 and calls on Congress to pledge whatever resources are necessary to accomplish this goal, to include medical, rehabilitation and employment assistance to homeless veterans and their families. **HR499/113**

#### Quality education through Post 9/11 GI Bill

As one of the founding authors of the original GI Bill, the American Legion wants to protect our veterans with programs that include provisions to evaluate post-secondary education institutions on quality factors such as accreditation, affordability, graduation rates and acceptance in the job market. State approving agencies should be assured their original power to protect the GI Bill along with additional funding to ensure their mission. Servicemembers should be allowed to open tuition loans regardless of residency status. **HR337/113/113**

#### Military to civilian credentialing

DOD spends a lot of money training our military. The skills learned need to directly translate to their civilian equivalent, and standards verification is a long endeavor. Cooperation among the American Legion state governments, private sector employers, institutions of higher learning and the federal government is essential to effect the necessary changes in policies and practices to fully recognize military education, training and experience. We encourage congressional efforts to engage their state and local officials to address credentialing issues within their respective states.

#### The American Flag

The American Legion remains committed to protecting Old Glory, and continues to support legislation that safeguards our nation's flag from physical desecration. **HR499/113**

The Congressional appointment times and places obviously differ for each visitor, so we select a meeting place afterwards to coordinate travel back to the hotel. Our contingency has met after all Congressional visitations for debriefing at “The Dubliner” restaurant in Washington, DC for the past 7+ years. We presented them with a plaque officially noting that their restaurant is the official meeting place of the Detachment of NY Sons on the Washington, On-the-Hill Days. It will be proudly displayed in their restaurant. Danny Coleman (Syracuse, NY native) accepted the plaque with appreciation.

**Our second main legislative event was held on March 12 - March 13, 2013 when the SAL Detachment of NY attended the On-the-Hill Days in Albany, NY.**

Seven members of the New York Detachment were present: Commander John Knapp, NEC Jerry Ketchum, Past Commander Dave Bishop, Asst. Adjutant Christopher Burtch, and Detachment vice Commander Thomas Farrell, Detachment Legislative Chairman Doc Gibbs, and Sons member Charles Duffy from Mt. Kisco Squadron/Westchester.

The Legion had several items to address as issues (17 in all). The focus after the briefing meeting held on Monday evening at the hotel seemed to be the fact that each County should have their own independent committee that serves veterans; it should not be combined with the office of the ageing or social services. Erie County has that problem solved but other smaller counties still suffer from in-direct representation. The SLA 30 day billing cycle and the Pledge of Allegiance issue is still on the docket as well.

We each visited our respective assemblymen after having breakfast with some legislators at the hotel. We typically sit by county and do the visitations with Legionnaires from the counties. I personally visited the offices of Michael Kearns, Crystal Peoples, Timothy Kennedy, Patrick Gallivan and Raymond Walter. All are assemblymen from the general Erie County area. We got commitments from two assemblymen (Kennedy and Peoples) while visiting to co-sponsor some pieces of legislation.

- 1.21 **Leading Candidate for National Commander; Joseph Gladden (MD) was introduced by N.E.C. Ketchum.** Candidate Gladden spoke about he became a member of the Sons of The American Legion. Since then has made a lot of friends in the Sons. He stated that you do more for friends than for strangers. I went to my first meeting and started to hear about all these programs that the membership is supporting and sponsoring, I.E. CWF, CMN, NEF, V.A. &R., Americanism, and C&Y. Those things did not mean that much to me at the time. It was through the friendships that I actually learned about the programs and started work on them. I then started to learn what true Americanism is. I learned that our Veterans are what true Americanism is. What they have done for our County and the sacrifices that they made is what Americanism is about. I never had conversations with my dad about what he did during the War. I found out that he was an M.P. in Germany. I learned that my Fathers service was important. My project next year will be the

American Legion Legacy Scholarship Fund. Commander Knapp presented candidate Gladden with a check for his campaign fund from the Detachment.

- **The Commander Recessed the Convention for Lunch, we will reconvene at 1:15PM**

**1.22 V/C Santa-Croce** reported well, it's been 8 ½ months since Sandy wreaked havoc with portions of all five counties in the 2<sup>nd</sup> and 10<sup>th</sup> Districts. As you look at the progress being made in these areas, it ranges from complete restoration to "nothing has changed" from that October 29<sup>th</sup> day. In our five counties, most of the beachfront areas and the related businesses have reopened, except for some that just decided to close down. Gary Denmon will be happy to know that the 4<sup>th</sup> of July Nathan's Hot Dog eating contest was held in Coney Island. Also half of the New York Aquarium in Coney Island was reopened but will not be fully available until 2016. In Staten Island, you see the progress that has been made, but then you realize there are neighborhoods in New Dorp Beach and Oakwood Beach that are still waiting to find out whether the State is going to declare their homes condemned and buy them out. Meanwhile these properties remain as they were on October 30<sup>th</sup>. In the aftermath of the storm, Sons from the Cespino-Russo and Granito-Smith Squadrons did great work in the community distributing food and baby supplies in these areas. In Queens, while some residents in Rockaway are back in the homes, some are not and the people in Breezy Point are still waiting to find out how the government is going to help them after the Sandy-related fire destroyed over 200 homes in this beach community. The sticking point in these areas is waiting for the federal government to decide if the residents have to rebuild their houses a certain number of feet off the ground. If that decision is made, it would force the residents to comply with the law or face ridiculous increases in the insurance. Nassau & Suffolk Counties, for the most part are back to normal, but don't tell that to the people in Long Beach who are still awaiting help in getting their neighborhoods rebuilt. Most noteworthy in this area was the effort of members of the Babylon Squadron, who banded together to make emergency repairs on houses in their community. As for the American Legion, all five counties are basically back to normal in scheduling their activities. In Queens, the repairs to the Broad Channel and Rockaway Legion Halls have been ongoing and the Halls are in use, even though the work continues. The Oceanside Post in Nassau County suffered major water damage on their first floor, but repairs have been made and the building has reopened. In all, 198 grants were approved under the National Emergency Fund with over \$120M distributed to Posts and members of the Legion families.

As for my activities: **February 3<sup>rd</sup>**- 4 Chaplain's Service at Fort Hamilton Army Base **March 3<sup>rd</sup>**- Legion Family Past Officers Dinner was held in King's County where last year's Commanders of the Legion and Sons were honored in addition to the Auxiliary President. **March 16-17<sup>th</sup>**- The Department Officers were hosted by Nassau and Suffolk Counties as the Visitations cancelled last November were held. **April 13<sup>th</sup>**- I attended the Legion's CWF Fundraiser **May 26<sup>th</sup>**- I was an invited guest and gave an address at the King's County Memorial Day commemoration at Cypress Hills National Cemetery. **May 27<sup>th</sup>**- The annual Memorial Day Parade was held in Bay Ridge Brooklyn. Legionnaires, Auxiliary members and Sons marched together. Color Guard was made up by 3 Sons.

**June 12<sup>th</sup>**- Attended the Wounded Warriors Dinner in Richmond County. My squadron purchased a table along with the George Washington Squadron. The event was organized by the Richmond County Knights of Columbus and the united Veterans' Organization of Staten Island. Over 650 people attended the event with over \$23,000 was raised. A guest at the dinner was Bryan Dilberian, a young man from my neighborhood who played basketball and baseball with our Sports program as a young teen. Bryan is a triple amputee from his service in Afghanistan. He will be the second recipient in New York City of a customized "Smart Home", which will be built for him in a joint effort of the Stephen Siller Tunnel to Towers Foundation

and the Homes for Heroes Foundation. The house will be built in Staten Island and the funding is already in place.

Membership- District 2 did a nice job of getting the membership in and was the first district in the Detachment to reach 100% for the year. At the other end of the spectrum we have the 10<sup>th</sup> District that had a tough year with membership, which could be Sandy-related. Both Districts did great in signing up new members as a combined 183 new members were signed up this year. This doesn't sound like much, but you have to realize that number represents 10% of the combined membership of the two Districts. But, what this also indicates is that we are having trouble with renewals as we have over 250 members that did not renew their membership. Again, this could be Sandy-related but in our area we do have a different issue that, as the younger Sons get older, they eventually move out of the city and lose contact with their Squadrons. We have to do a much better job in retaining our existing members. In Kings County we have been able to extend their activities and we have also co-sponsored more events with the Legion and the Auxiliary. In 2013, the Kings County Sons contributed \$1,250, to CWF and over \$2,800, to the Walkathon with the help of the ladies of the Auxiliary. While accomplishments are good in the County, it is achieved the hard work of a core of dedicated individuals. We need to reach out to our squadrons and get more people involved with County activities. I've already had conversations with the incoming County Commander to work on plans to achieve this goal. Marie has been working closely with the hospital to find ways to make the hospital stay for patients in the transplant unit a little more pleasant. While they're working these ideas, one goal she had has come to fruition. Last month we purchased 10 Josh Dogs and delivered them to the Komansky Center for Children's Health at New York-Presbyterian on behalf of the Windsor Terrace Squadron and Auxiliary. The staff is being judicious in handing out of the dogs and wants to present them to children that they think will benefit the most from the "story of Josh."

- 1.23 **V/C Depo** reported; Squadron 20, The Sons worked a Chicken & Biscuit dinner for the benefit of the American Legion. They worked about thirty hours on May 31<sup>st</sup>. Flag retirement day dinner, the Sons cooked a Spaghetti dinner on June 14<sup>th</sup>. The Sons worked Thirty-two hours. Bottle Drive was held on May 24<sup>th</sup> & 25<sup>th</sup> the Sons worked Twenty-two hours. These three events were worked the Legion family. The Sons attended the Flag retirement service at Post 20, also attended the Memorial Day service. Two Scholarships of \$500.00 were given out this past June. Two Sons from Squadron 20 received them. The Legion family is coming together very nicely and is working great to get things back to the way they were. The Sons sponsored three dart teams \$150.00. get a chance to attend do so. They start in September to get ready for February's winter fest. The Sons put on a rabbit Derby in March. Three different Classes, women, men and kids prizes were given out to three places in each class. Moneys made help support, food baskets, Children and Youth, scholarship, Metrical network. The Sons give out about \$4,000 for their projects or more. There number of hours is 600 hrs. There dinner is always a great success. They help with many benefits such as Cancers of all kinds, family in need of food, Medical, almost anything. 1619 Squadron does a great job working with Auxiliary, Legion and Legion Riders. A great Legion family

#### Squadron 1618

The Sons work at the Post doing whatever is asked of them from Cooking, serving, attending funerals. They also donate to Charity's and to their Community in any way they can. The Sons work all the Legion Holiday events, Memorial Day, Veteran Day, Flag retirement service, plus participate on Color Guard for funerals. Sons Co-sponsored the Children's Halloween and Christmas parties cost \$300.00. The Sons sponsored there annual golf tournament for their Scholarship of \$500.00. They cook the annual Chicken Bar-B-Q, cabin fever night. The whole town comes out for this event. The Sons work to raise funds for little league and youth Soccer. They held a TV raffle and raised \$400.00. The number of hours they worked was 394.

#### Squadron 701

Squadron helps out with their annual Christmas dinner. They severed over 1,200 meals with total hours 1,300. They hold their annual Chicken Bake/Poker run to raise funds for their project, Scholarship; they have Boys State, \$300.00. They also have a breakfast for the Boys going to Boys State. They hold Sunday cook-outs at the post. They do Various Chicken bakes for Charity.

#### Squadron 1450

They did an Easter egg hunt and severed Breakfast with the Easter Bunny. There Breakfast severed about 150-300 people the Community really supports Squadron 1450. They help children in foster care with clothing and essentials. They donate money to local High Schools around \$2,000.00 that goes for lunches for students who might not meet the criteria to get a nice lunch while at school. They also sponsor Boy Stat, \$300.00. The number of hours worked by this Squadron is 1,000 to 1,500 at their breakfast and Chicken and Lobster bakes

#### Squadron 111

Quarterly food shopping for family of 11 spending at least \$150.00 each time. Purchasing and receiving (through donations) contents for Holiday bags these are assembled and delivered to the Five Senior Citizen homes in the Ellenville area along with bags for each person in the local Hospital 20 items are given to each person. They also do the placing of Flags on graves of Veteran in five cemeteries. Two scholarships were presented to Graduating Seniors for meeting Son's Scholarship requirements. 

- 5.01 **A motion was made by Ontario County to support Joseph Gladden for National Commander of the Sons of The American Legion. The motion was seconded and carried.**


- 5.02 A motion was made by Ontario County to support Robert Turner for the office National vice Commander. The motion was seconded and carried.**
