FIRST SESSION – JULY 14, 2016

- Commander Santa Croce called the Convention to order at 9:00 AM.
- The Colors of our Nation were placed by the Detachment Color Guard and the body saluted.
- Commander Santa Croce recited the POW/MIA Ceremony as the Master Sergeant placed the POW/MIA banner.
- Chaplain Ellis offered the Opening Prayer.
- V/C Bosford led the body in The Pledge of Allegiance.
V/C DeAngelis led the membership in the Preamble.
- Adjutant Robert Avery read the Call to Convention, Roll Call of Officers, and Roll Call of Counties, which indicated a quorum was present. Present as a guest to the Convention was Sons of The American Legion Judge Advocate Joe Paviglianti (NY) Sons of The American Legion National Commander Kevin Collier (AK).

1.00 REPORTS

1.01 Convention / Binghamton General Chairman Tom Smallcomb welcomed us to Binghamton and to Post #89. If you have problems with the hotel accommodations let me know. There are busses running from 6PM till 1PM tonight and tomorrow night to the post. We will be having entertainment.

1.02 Americanism Chairman Myrtle reported it has been my honor and privilege to serve as your Americanism Chairman this past year and would like to thank our commander for entrusting me the position. Thank You Commander! Before I begin I would like to acknowledge and thank all of the members of the Americanism Commission for their participation and support this year. James Daly of Rochester ; Jim Parks of Ontario; Dennis George of Rome; Charles Depo of Chazy and Michael Rodriguez of Brooklyn, NY with their help we have made it all work this year. Please join me in showing them our appreciation. During Fall I had the opportunity to attend an American Legion Americanism conference in Indianapolis and did a study program on the Oratorical contest. This is an American Legion contest for high school student on the Constitution and Bill of Rights. Scholarships are awarded throughout our states and a finalist from each state complete for a national level scholarship.

1.03 Children & Youth Chairman Hodge reported Consolidate Reports that were turned in was pretty low. Only had 99 Reports turned in this year, don't forget that the consolidated reports are an important thing that has to be done, don't forget it is great to toot our horn, and so don't forget to turn them in. Again I had 99 reports turned in, 71 reports that were judged 28 not judged (Filled out wrong incomplete) Member #'s Wrong, Dates. If you need any help just ask. We are all here to help, Squadron Commanders, County Commanders, District Commanders and Advisors ask for help if needed. We had 11 reports at 150 Members or more. We had 60 Reports at 149 members or less. We had 28 Reports with no donations or hours to report, and 1 District Report the 5th District. Here the totals; \$15,972 donated to the Child Welfare Foundation, total hours for CWF 1,357 hrs. \$24,227 donated to the Special Olympics, and 2,284 hrs. Served, \$22,826 donated to the Children's Miracle Network and 809 hrs. Served, 12 Josh Dogs given at a cost of \$465, \$320 donated to Operation Military Kids along with 190 hours given, \$36,167 to other C & Y Projects with 13,670 hours given. And the awards go to,

1.04 The Finance Chairman Lee; Thanked the members on the Finance Commission for their work and commitment. He read the current budget and where we stand to date. Finance Chairman Lee read the proposed budget. He also stated the office staff, accounting firm and the investment firm have been a great help with communicating where we stand at any given time which helps us with setting up our budget. There was a question regarding how much money we currently have in our investment account. The answer is approximately one and one half of our annual budgets. That is a guideline that our accountant firm has suggested we have at any given time.

Broome County made a motion to accept the budget and report as read which was seconded and carried.

1.05 Internal Affairs Chairman Williamson had the following Chairman give their reports. **Membership Chairman Gaither Espy** reported Membership- What is membership? Membership is the lifeline of our great organization. Without membership we have no organization. Who is responsible for membership? We all are responsible for membership, from Detachment Commander Joe right down to the member who joined today. Through this past year I have been in contact with the Detachment membership commission members, Detachment Vice Commanders, District Commanders and other past or current officers across the State. The goal of this communication is for the information received on the Detachment level, gets filtered down through the levels of our organization to the blue cappers in our Squadrons. 95% to 100% of this information does make it to our Detachment web site@sonsdny.org. Please do not think we are nagging you about membership. We are trying to get membership goals and membership tools out to you, to make your job easier. This year right before Mid-Winter we did reach our 60% target date. It was the only one reached this year. We seem to be a week off reaching these. Our Detachment currently has 28,903 members paid for 2016. This puts us at 98.56%. This is only 421 members shy of our goal. Unfortunately we have 9 Squadrons throughout the State who have not even transmitted. The membership goals of these 9 Squadrons account for 212 of our members needed. We currently have 4 Districts, 27 Counties and 191 Squadrons who are at or over 100%. Congratulations to all of you, great job. There are 2 Districts and 15 Counties that are so close I can taste it. Throughout the State we have signed up 2,665 new members. This is great, but at the same time we

are seeing 3,086 members not yet renewed. Our current renewal rate is 89.03%. Gentlemen, the members are out there. We need to reach these guys and get them to renew. On the National Level, New York is currently in 35th place. 19 States have reached their 100%. 4 of those States are in comparison with our membership numbers. So yes it can be done. Within the Eastern Region we sit in 7th place from 14 Detachments. The 1st District has been leading this year with 109.43%. The 2nd District has been right their heels with 103.57%. The 7th District not to be forgotten comes with 100.85% The 5th District our largest 100.10%. Once again, great job to these Districts for reaching over 100%. The 10 District 98.45%, 4th District 97.84%, 8th District 96.25%, 6th District 95.95%, 9th District 95.76% and bringing up the back the 3rd District 94.89%. Our top 3 Counties are Warren County in the 4th District 130%, New York County in the 1st District 118.33% and Schoharie County in the 3rd District 116.67%. As for our Vice Commander's, with a combined total of 100.39% is Vice Commander DeAngelis from 2&10. Followed by V/C Clancy 98.82% 1&9, V/C Coates 98.82%, V/C Burch 98.70% 5&6 and poor V/C Bosford 96.88% 3&4. Annie in our Albany office has the 2017 membership cards ready to be mailed IF your Officer Certification Form has been mailed. So if your Squadron has not gotten your cards, please make sure you get that O.C.F. mailed. Once cards are received please get started on your 2017 membership year. Our 1st target date for the 2017 year is September 14, 2016 for 10%. In conclusion I want to express my thanks to the membership commission on a great job this year. To the Detachment Vice Commander's, District Commander's and the entire membership, thank You.

MT&D report read by Chairman Jarvis; the leadership class and Advisors seminar were given at Mid-Winter. The Committee will continue to review and update the programs as needed. The committee is looking at giving away thumb drives as handouts instead of cd,s. We will have more information at the Fall D.E.C meeting.

Convention Chairman Smallcomb reported welcomed everyone to Binghamton. If you have problems with the hotel accommodations let me know. Chairman Williamson read resolution 2016 DC-1 "Sons of The American Legion Everlasting" submitted by Cassadaga Memorial Squadron #1280.

Onondaga County motioned to accept the internal affairs report minus the resolution which was seconded and carried.

1.06 Parade Chairman Junker reported that the parade will be Friday and will start at post #80 at 6:30PM and will be just less than one mile long. You can register here forms are available. You will have a chance to meet the judges at 2PM and they will go over the rules. The results will be available on Saturday.

1.07 Cassie Green Broome County Chamber of Commerce that us for being here. She thanked us for choosing Binghamton for our convention. Enjoy your stay and if there is anything I can help you with please let me know.

1.08 Public Relations Chairman Coates reported the active portion of the Legislative agenda began on February 21, 2016 for the American Legion Legislative On-the-Hill Days. Seven members of the Detachment of NY participated in the Legislative weekend: Ken Kraetzer, Charlie Duffy, Natl Legislative Chairman David Lee, Commander Joe Santacroce, PDC Ray Jarvis, leading candidate Bruce Ruthven, and NY Legislative Chairman and PNVC Doc Gibbs. All appointments for Congressional visitations were confirmed and made in advance. When we all arrived in Washington, we were prepared with notebooks with maps, appointments, and legislative points were given to all participants. This legislative trip was the most bizarre over the seven years that I have been helping to organize them. We were unable to stay at the headquarters hotel so we had to travel by cab to and from our hotel to the headquarters site for meetings, I got sick on Saturday and was confined to bed for days, missing several important meetings and appointments. Ray Jarvis also got sick a day later and similarly was also out of

commission. Bruce Ruthven and Joe Santacroce were the healthy survivors of the original travelling group and did make their congressional meetings and attended the Know before You Go sessions as well. They also managed to have a tour of the capitol building while in DC. Several of the Congressmen were not in DC this weekend so meetings were held with aides, Bruce Ruthven did have a meeting with his Congressman along with several other Legion Family members (see photo). Charlie Duffy was complained by his family and he made his own plans and met with his representative as well. Ken Kraetzer had a meeting with the Superintendent of the Arlington Cemetery while there to continue plans for his Chaplains' Hill Monument and walk-way Project.

Since this is a presidential election year issues were not as forthcoming as usual, the legislative priorities were the exact same ones that were presented last year, so no major re-education process was necessary to prepare the Legion Family members as they brought those issues to their Congressmen. It was an unusual year of illnesses and multiple cab rides and cancelled appointments. Follow ups with Congressional offices was held to keep the integrity of our initial plans and responses from our representatives seemed as strong as ever.

For the On-the-Hill Days in Albany, New York scheduled for February 29- March 1, 2016; we had a contingent from the Detachment of New York present as well. Doc was unable to attend due to travel plans for Alaska that same week for the Natl Cmdr. Collier's Homecoming. Commander Joe Santacroce and Leading Candidate Bruce Ruthven attended the Legislative Breakfast along with ANEC David Bishop, and went on up to the hill immediately afterwards and met with their local representatives to share the Legion priorities in our state. Commander Joe Santacroce got one of his local representatives to co-sign a bill that involves sending un-claimed remains of veterans to the American Legion for further honorable disposition. This is a bill that has been in the house for a while and we are hoping for action on this congressional year. While we were in Washington, D.C. several many members of the Detachment of New York contingent attended National Vice Commander Bill Hill's homecoming events in Maryland just prior to the On-the-Hill Days. Ray Jarvis, Bruce Ruthven, Joe Santacroce and Doc Gibbs attended the Eastern Gathering hospitality for leading candidate for National Vice Commander East from New Jersey Joe Korba and attended the homecoming dinner the next night for Bill Hill from Maryland. We have had another successful legislative year at the Detachment level, in spite of the craziness of the actual Washington, DC visit itself. Much has been accomplished during the on-the-hill days. After a banner year last year with Commander Helm - Congress is now paying attention to the National Commander Barnett at the various hearings and this has been a good legislative year for our Detachment and the Sons in general with progress being strengthened in many areas.

We have also had several official “Action Alerts” this spring since our face-to-face meetings on the hill. These alerts require immediate attention by voters since specific “Legion impacting” bills are being considered. When those action alerts come to my attention, they are immediately forwarded on to our Detachment and National contacts as appropriate. It appears that, although this is a presidential election year, some legislation is being pushed through without all the usual notification and within some bills are roll-backs on some of the issues we thought were solid. We not only must continue to support new legislation and oppose legislation that does not serve our constituency but we also must be on guard for roll-backs that threaten legislation that we have already had passed, specifically elements of the New GI Bill that was passed just a year ago or so. Please stay in contact with the Legislative Commission from both our Detachment and the National organization so you can act in a timely matter and influence legislation that impacts our veterans and our military. I remain on Congressman Collins Legislative Veterans Advisory Committee which usually meets several times a year. During this past spring Congressman Collins passed a bill that allowed women members of the WASPs (Women’s Air Service Patrol) to be buried at Arlington Cemetery in Virginia. Many SAL members wrote to our congressmen about the issue of a women being denied burial because she was not considered a “veteran”. The Congressman acted quickly and within 3 months was able to get such legislation passed. We can make a difference through our impact as voters and Legion family members. The Congressman’s next committee meeting is scheduled for Sat., July 9, 2016 in Batavia at the Legion Post. At this meeting there were about 25 people present from many different service organizations (the big 6). I was the only Sins member present. The Congressman updated everyone on his efforts to open the new VA Clinic in Rochester as well as updated us on the planning of the new National Veterans Cemetery. The cemetery is planned to open in 2018-2019 for burials. When the construction phase begins a ground breaking ceremony will be held, hopefully in 2017. Funding has already been earmarked and things are on schedule. Collins big push is for the passing of HR 2218 – Renovation and Enhancement of Veterans Meeting Halls. He has over 31 co-sponsors including Congressmen Higgins and Congresswoman Slaughter. This bill will help Posts secure grants to fix their posts and it is hoped that this will pass during next year’s Congress. He is also pushing for the HR 4640 bill – the Veteran Suicide Prevention Act. Canandaigua still has the only veterans’ suicide hot line in the country and it has its problems as well. He is also pushing for the VA funding to increase 4% from this year’s levels; improve the VA health electronic record data exchange, and a plan to attack the Claims Backlog. He encourages people to contact his office if they are having delays in medical issues and his staff will try to cut through the red tape, etc. It was a fruitful meeting that went on for about 1 ½ hours. He had much time devoted for open questions from the floor. His parting comments were to make sure that people vote and elect a veteran friendly president. He has mentioned a level of disappointment in the current administration on that front.

Erie County made a motion to accept the report which was seconded and carried.

- 1.09 Public Relations and Webmaster Cinquegrana** I would first like to acknowledge the members of our Commission: Jim Coates, Timothy VanPatten II, William Clancy, Kevin Harrington, and Ken Kraetzer. We are all there to help and assist, so please call on us at any time. Our contact information is on the Detachment Website and on the back page of The Liberty Newsletter. Speaking of The Liberty, thank you to everyone who submitted information and pictures for the Convention issue, which was emailed and posted last week. It is really important that we continually herald what we do, and tell people and show them what we participate in and what we can accomplish. There are also hard copies of this issue available here at Convention. I am also happy to report that we received word that The Liberty has been named 3rd place winner of the George W. Hooten Award by the National American Legion Press Association. Thank you to everyone’s input, helping to make that happen. As you may recall from Mid-Winter, we were very successful at our first Public Relation’s Project at a statewide event, collecting over 800 personal care items for Catholic Family Charities in Albany. We agreed to continue that, and here at Convention are conducting a sale of tickets for a \$100 Lottery

Tree; proceeds to benefit the local Southern Tier's Twin-Tier Honor Flight Program. We will be selling tickets at the Auxiliary and Legion locations, and will draw the winner on Friday afternoon. A presentation will be made Saturday morning. We will then be looking forward to the Fall DEC for the next PR project to benefit a local charity. SAL Radio, directed by our own Ken Kraetzer has done some remarkable things this year and continues to represent the Sons in a number of events at the highest levels. SAL Radio has received State and National recognition, including 1st place this year by NYALPA, and has been at the center of work being accomplished on Chaplains Hill at Arlington National Cemetery. Ken is also working on a plan with the Metro Atlantic Conference, Iona, Manhattan, Marist, Siena, Niagara, and Canisius, to provide color guards to their men's and women's basketball games and other veteran support activities. This is great exposure potential for the SAL, and anyone interested in helping is welcome and should contact Ken. We continue to tweak our Website, hopefully making it a useful tool for everyone, as well as an easy source for information. We hope you check it frequently, and please get on the mailing list if you have not done so already. If you just want to send me an email, I will do it for you. After the Convention, we hope to start our review of our current PR tools and PR Manual, and provide updates and additional information that can be useful to everyone. I know I always repeat this, but everything you do, is as a representative of the Sons of the American Legion, and is thereby the face of the Sons of the American Legion to the Public. We need to remind ourselves and our members, and train our membership, on the importance of Public Relations and how to accomplish it effectively. Our Commission's plan is to help you do that.

- 1.10 V.A. & R. Chairman Cox** reported Since the Mid-winter Conference one of the primary concerns of the Commission has been promoting the Walk-a-thon. Through the efforts of many, including the Auxiliary, We were able to do better than last year, although we were still down from some of the previous years, We raised \$20,600.00 which will be divided evenly between the Sons and the Auxiliary with a check presented to the Auxiliary by Commander Joe, myself on Thursday morning. The members of the Commission met briefly last night to review the results reported on the Consolidated Reports and also judge the William P. O'Connell Scholarship. Although the awards will be presented later, here is brief summary of the numbers. We had 563 visits for 6,097 hours and \$16,891.00 to Veteran's Homes; 1,334 visits for 7,422 hours and \$18,671.00 to VA Hospitals; 2,744 hours of field service and 2,227 hours of home service; 58 hours and \$1,985.00 donated to Fisher House; 2,517 hours and \$25,656.00 donated for troop support; 1,923 hours and \$4,765.00 donated for family support; 3,895 hours and \$77,471.00 donated for other VA Projects; 309 veterans assisted with 630 hours and \$1,468. 00 on Veteran's Assistance Day; and \$9,687.00 donated to the Comfort Warrior Project. I have not calculated a statewide percentage of squadrons submitting reports, but based upon my district we are receiving reports from about 1/3rd of the squadrons. Think about what the above numbers would look like if we multiplied them by 3. After a review of these numbers by the Commission, we picked the following squadrons as this year's award winners. The awards are based on an overall body of work. Some squadrons have reported impressive numbers for individual categories, but very little in other areas. For squadrons with 149 members or less; 3rd place goes to Maine Squadron #1390, 2nd place to Melvin Roads Squadron #1231 and 1st place goes to Michael A. Rawley Jr. Squadron 1636. For squadrons with 150 or more members the awards go to; 3rd place goes to New Hartford Squad #1376, 2nd place goes to Chili Squadron #1830 and first place goes to Seeley B. Parish Squadron #457. Unfortunately, as usual, we had quite a few reports that did not have the prior and current year membership enter and also a number of reports that arrived too late to qualify for judging. Some of these reports had impressive numbers. Those numbers have, however, been entered into the overall results. We also reviewed the applications for the William P. O'Connell Memorial Veterans'

Rehabilitation Scholarship. This year's winner is Gannon Frisbee, a 10 year member of Downsville 167 Squadron. Gannon will be attending Clarkson University. I continue to volunteer at the VA Hospital in Syracuse have over 3,000 hours of service to our veterans. I encourage everybody to consider volunteering. You will find it a very rewarding experience.

Onondaga County made a motion to accept the report which was seconded and carried.

- 1.11 2nd District Commander Rodriquez** reported that they have solicited local schools to participate in the Essay Contests conducted by Detachment Sons of the American Legion, March to June – Assisted in obtaining 11 candidates for the American Legion Boys State Program, 7 Boys did complete this program, 4 dropped out of the program, also raised over \$5,400.00 to pay for transportation and the boys state program. Kings County Sons of the American Legion sponsored one boy. Assisted Bob Myrtle by reviewing 87 2nd grade essays “What America means to me” and reviewed 4 scholarship submissions, April 3rd – attended the “Four Chaplains” ceremony at Fort Hamilton Base. June 5th – Swore in newly elected S.A.L. officers of Floyd Bennett Squadron #1080, June 17th – had the honor of swearing in newly elected S.A.L. officers of Kings County, this was conducted at Kings County Convention

Brooklyn County made a motion to accept the report which was seconded and carried.

- 1.12 The 3rd District Commander's report was read by acting Commander Bill Baker;**
Good Afternoon: Commander Joe, Adjutant Bob, Detachment Officers and Fellow Sons. I am not able to attend the Convention this year and my report will be read by our Second Vice Commander, Bill Baker who will be representing me throughout our sessions. At this time, I would like to introduce myself; I am Bill Baker Past Squadron Commander of Melvin Roads Squadron #1231 in East Greenbush, NY. I became a member of the Sons 6 years ago and have not looked back since. I became fascinated with the work of the American Legion family from the first moment I stepped into the Melvin Roads Post. As a proud Husband and Father, Son, Grandson and Brother of Veterans I found it was profound honor to assist in any way I can, I am looking forward to serving this coming year as Third District Commander

- 1.13 The 4th District Commander Martel's report was reads by acting commander Tim Williams** the Biggest though I would like to pass on is the (SRPC) The SRPC is a place for Homeless Veterans with Warren, Washington, Saratoga and Montgomery County and Squadrons, all add to help this cause. Many Squadrons are doing fund raisers for local

Scholarships, Children & Youth and Supporting the National Commander project. Riders are adding to the Legacy fund and it grows every year.

Saratoga County made a motion to accept the report which was seconded and carried.

- 1.14 5th District Commander Cox** reported; First of all, I would like to thank the Sons of the 5th District who placed their trust in me and assisted me over the last two years. I would also like to congratulate Dennis George who will be the new 5th District Commander. Since the Mid-winter Conference I have been able to attend County meetings in Oneida, Oswego and Onondaga Counties. I also participated in the Oneida County Sons Golf outing with the proceeds going to help Sitrin Group in Utica, a Veterans support group. I enjoyed the National Commander's 5th District visitation in Little Falls in Herkimer County. I also helped place flags at two cemeteries in Skaneateles and marched in the Skaneateles Memorial Day Parade with a large group of Legion and Sons members. I would like to thank those squadrons of the 5th District took the time to fill out and submit their Consolidated reports. We need you back to go back and get the squadrons get more involved with or oratorical contest. Children & youth Conference will be held this year September 16th and 17th in Indianapolis. Child welfare foundation reported a total 24 grants worth \$640,395 was voted on at the fall conference by the foundation. Finance commission discussed the possibility of a dues increase but at this time they do not recommended a increase but the matter may be looked at in the future. Membership committee recommending we really push this year to get the member profile cards done this year when member pays their 2017 dues. But one of the biggest moments came when PNC Cerullo, Adjutant Avery and Detachment Commander SantaCroce present Joe Paviglianti a copy of the Resolution in memory of Al Paviglianti. Up next and last was the joint homecoming which I thought went very well and was well attended.

Broome County made a motion to accept the report which was seconded and carried.

1.32 Department President Mahoney thanked us for the invitation to address the Sons. She thanked for electing Commander Joe, he has been a pleasure to travel with. He is knowledgeable, genuine and dedicated to the principles that the Sons adhere to. We need to continue to work together on our programs and membership. I have met so many sons who have made a positive impact and have it easy to walk this road. Joe's quiet and friendly manner with a quick smile have made being with Joe on this journey has made this the most favorable, memorable thing I am going to remember in this chapter of my life.

1.33 Master Sgt.-at-Arms Falco gave his report. There have not been too many fines this year; only \$79.00 has been collected. He thanked his Assist Sgt. At Arms and the Binghamton County sons for their help at support.

1.34 Adjutant Avery reported. Congratulations to all of our membership on a terrific year, especially the blue cap members who worked so hard raising monies and working the events at the Post level. Your dedication is exemplary! Our parent organization, from which we exist, is also thankful for all of your efforts. Many Posts would not be able to survive without a concerted family effort by Legionnaires, the Auxiliary, the SONS, and the Riders. I also thank the Detachment officers and committeemen for their commitment, working our programs and helping us to raise the funds that we donate each year. I especially want to thank our Detachment Commander Joe SantaCroce who (in case you were not aware) did a fantastic job this year as he traveled the State's 62 counties with Commander Jim and President Jan. They made a terrific team, and our Commander thanks all members who presented donations to him during the visitations, and also thanks everyone for their involvement in this year's Walk-a-Thon. As for membership, the July 5th report puts us at 98.92% of goal, needing 421 members to reach 100%. We are in 36th place in the Nation and within the Eastern Region we are in 7th place. Our figures are an improvement over last year at this time. As a matter of fact we are over 700 members above last year. We are still the 4th largest Detachment in the Nation. We are STILL separated by 2,000 members from Ohio. As we wrap up this membership year, everyone's assistance is needed in bringing in those last renewals. Let's be at 100% when we arrive in Cincinnati for National Convention! 2017 cards have been mailed to all Squadrons who have submitted an Officer Certification Form (OCF) for the 2017 year. Send in your OCF if you have not done so already. The first Target Date will arrive quicker than you think!

Monroe County made a motion to accept the report which was seconded and carried.

1.35 Commander Santa Croce gave his final report. I want to take this time to thank all members of our Detachment for their service to our veterans this year. Traveling throughout our great state was such a rewarding experience as we visited all the sights that are a source of pride to the citizens of that particular area. We also had the opportunity to meet so many great people in all corners of the state. Thank you to the Vice Commanders and District Commanders who accompanied Marie and I on our tours through the Districts, for not only making our visits more enjoyable but also for their friendship. I also want to thank all Sons who attended the Visitation dinners and made donations to my projects, Operation Comfort Warriors and the American Legion Legacy Scholarship Fund. I also want to thank the Commission Chairmen and all the members of the Commissions and Committees for their hard work this year and for assuring that our Detachment is focused on supporting our Legion programs. Since this is my last opportunity to address you as your Commander, I would like to make a few observations based on what I have experienced over the past year. I feel we have a great nucleus of hard working members here in our Detachment. I also think we have some very active squadrons in our communities. But I feel that in too many of our areas we have a lack of succession between the two levels. We have to identify our Sons at the Squadron levels that might have the ability to become County, District officers and possibly beyond. We have to try to eliminate the need of the same County or District officers serving year after year. The Detachment Vice Commanders and the District Commanders must work closely with their County organizations to assure that we are cultivating future leaders. Next year's Visitation schedule is already posted on the website!! Too many times last year it was me, the VC and District Commander attending the dinners without any local Sons. Too often I saw Sons during the daytime tour who said they weren't coming to the dinner because they just found out about it and couldn't get the word out. We need to get the word out to our members ahead of time and not wait for the counties to pass the word down. I ask that the Vice Commanders and District Commanders look at the schedule and work together to notify someone in each county so they can go to their County Legion leadership and make sure they are involved with the Visitation. We complain at times that we feel we do not receive the proper respect from the Legion in our area. Well, it's tough to make that complaint when we are no-shows at the visitation. I know it sounds like I'm putting the onus on our Detachment VC and District Commanders, and,

in a way, I am. As a Detachment we meet maybe 5 or 6 days a year. For the rest of the year, it is up to our local areas to make sure we are a successful organization. It's up to our VC's and District Commanders, as our leaders in the field, to lead the communication to the blue cappers to make they feel they are integral parts of our Detachment. As far as the Walkathon is concerned, I want to thank everyone who made contributions to this year's event. We were able to increase our total by \$8,000 to \$20,600. However, I think we can do better!! The reason I say that is because over \$16,000 of the total raised came from 5 counties!! That means the other 57 counties raised less than \$5,000. By the way, in those 5 counties, three sponsored Walkathons and two just solicited donations from the Legion Family and/or the community. I ask that we keep the momentum going next year and hopefully we can get more areas involved in this event which, I feel, is the primary reason why the Sons of the American Legion exist, to support our recovering veterans. Finally I would like to speak a minute about Operation Comfort Warriors. We raised over \$13,000 for this project this year, but now we have to make sure our local facilities realize the benefit of the program. Some of you know that as we were conducting our visits this year, Commander Jim would ask the staff of the VA Hospitals if they heard of OCV. In almost every case, the answer was no. This was disappointing since there were always members of the local Legion Family that were volunteers at the facility. During the past six months Gabe has obtained a grant for the Canandaigua VA and I recently had a grant approved for the Brooklyn VA. I ask any of you who volunteer at your local VA Hospital to please make use of this program. The process is extremely easy and the money is readily available for their use. Your Squadron can be a sponsoring organization. If you have any questions about the program feel free to contact Gabe or myself. There are also brochures available at Department. I was extremely proud to serve as your Detachment Commander this year. It was an honor to be your representative throughout our travels in the State. It was an experience I'll never forget. Again, many thanks for giving me this opportunity.

1.36 **Credentials Chairman Alex Anderson** gave the final credentials report which indicated 96 registered delegates.

Broom County made a motion accept the final credentials report which was seconded and carried.

- **Commander Santa Croce directed the Sgt. At Arms to place two pictures of Albert Paviglianti, Dual Member and friend of the Sons on the head table. He then placed his credentials there also dedicated the rest of the convention in his honor.**
- **N.E.C. Denmon introduced the National Judge Advocate and son Al, Joe Paviglianti.** Joe he stated that it is bittersweet and surreal to be here today. It was 49 years ago in this same Post and room that I became a member of the Sons of The American Legion. Though my father Al, we did lose him late last year lost him but we have not lost him. His presence is still here and with me every day. Joe state that although he does not live here his heart and membership will always be in the great State of New York. He stated that this Detachment is looked up to by many in other detachments and is well represented on the National Level. He present Commander Joe and Adjutant Avery with pins from the first ever New York Detachment Convention. Joe was presented a special certificate from the Detachment.
- **PNC Cerullo** thanked Joe for his support and guidance throughout the years he was my Detachment adjutant and I was blessed to have him as my National Adjutant.

for all you do to help the Legion. If it were not for your help in many posts there would not be any vitality. There was first this year, the Department Commander, Auxiliary President, and Sons Commander held a joint homecoming. This is good for everyone it helps bond and work together. When you go out and put this hat on represent this organization, be proud of yourself and this organization, wear the hat well and represent us well. When are in the community or the post or any meeting of any organization carry yourself on well, be respected and respectful it goes a long way it shows the professionalism organization.


5.00 FOR THE GOOD OF THE SONS


